Small Halls won't happen until 2023, Connie will contact them regarding next year's concerts.

At the next meeting we have to approve the budget.

- **f) Solar Update** Duncan reported that the committee has received 2 quotes and is looking for another quote. We are eligible for a grant from Region. The project is expected to be in the range of \$40-\$50,000. Duncan

reported that the United Church of Canada is supporting the reductio of carbon emissions through Faithful Footprints. This might include projects such as changing lights to LED - need assessment before and after...there are pros and cons – the grant can be up to \$20,000 for reduction with an extra \$10,000 to support conversion from carbon. Making a list of what we would want/need to change.
