### **ELGIN PORTLAND PASTORAL CHARGE TRUSTEE REPORT 2023**

Joint-Trustees of the Elgin-Portland Pastoral Charge are all members of either Elgin or Portland United Church. In all, the Joint-Trustees continued to monitor the operations of our Charge in 2023. We are primarily tasked with ensuring proper Insurance is in place and oversight of the rental of the Manse.

Insurance on the Clothing Cooperative, as operated out of the Country Roads Community Health Centre, is carried by The Bay of Quinte Mutual through Rideau Insurance. See further details in the Clothing Cooperative Report within. Directors and Officers Liability continues to be carried by Hub International through the United Church of Canada.

Insurance on the Manse is provided by Brokerlink in Perth. Rental on the Manse is received at \$1,400 per month. A new asphalt shingle roof, complete with new sheathing, was placed in the fall of 2023 with funds secured from past rent. Keith Wilson served the first part of 2023 as Property Manager before moving away.

In addition, the Joint Trustees held two social gatherings for the Charge. The first was a fish fry held at the Loonie Curling Club in the Spring. Many thanks go out to Roberta McKinney for allowing the space to be used and to Adrian and Anne Overdulve for organizing the food. In August, we celebrated the many volunteers of our Clothing Cooperative and specifically, the many years of dedication by their leader, Joan Kelly. A BBQ and time of fellowship, led by Jim and Anne Barton, was shared with about 20 volunteers and several congregants at Portland United Church.

On January 1 we brought in the new year with an excellent joint service in Elgin, capably led by Mark Bee, Pat Greenhorn, Clint Halladay and Cathy Ryan and the EPPC Choir. This was the first of 52 more thought provoking Sunday services led by a variety of worship leaders.

Rev. Kathy Walton helped lead us to Easter at which time we thanked her most sincerely for all the times she had led us in worship over the years. She is staying closer to home now for pulpit supplying – lucky Kingston! We were very pleased to have Rev. Shaun Seaman return to lead services on 13 Sundays in the warmer months (despite knee surgery.) Rev. Doug Powell led four services in his engaging manner (one on very short notice) and, also offering a Fall session Bible Study based on the book "God Is Closer than You Think". As well as doing Pastoral Care, our Liz Church led services on Good Friday, 8 Sundays from January to November, and then all the services through Advent and Christmas to December 31 offering us lots of inspiration and music. #### **EPPC YOUTH AND YOUNG ADULT REPORT FOR 2023**

2023 has been another year that has challenged the re-establishment of the Youth and Young Adults of our churches, but the Spirit does live on and has brought not necessarily youth inside the church, but in the community many opportunities where we have served our young people through the generous grant from the Vision and Transformation Team of the United Church of Canada filtered through the Elgin United Church to North Leeds Youth Council. We have continued to be a driving force economically for the work that has continued to be done through our local high school, five feeder schools, local municipal council events, the Village of Westport, the Rideau Lakes Library – Elgin Branch, Keys, Foley Mountain Conservation Area- Westport, local food banks, outdoor rinks, art classes, a movie license, and the Angel Coalition- Christmas gifts that St Luke's Anglican Church distributed at Christmas time.

Spreading the love of Jesus comes in many forms and outreach to these communities is what God is calling us to be. A voice in the wilderness, a helping hand, a tool to help meet not only the Spiritual needs, but the physical and emotional needs of our youth and young people. Our young people have had opportunities to share their many gifts, through music, assisting with Sunday School and ,various parts of the worship service.

As we go forward, we can once again to apply for the remainder of our grant of another \$5000.00 from the Vision and Transformation Team -United Church of Canada EOORC and we have met our part of the process in educating and embracing other forms of financial revenue to continue to be viable in our communities. Thanks to the Lion's Club – Westport, Rideau Pastoral Charge, St Luke's Anglican Church, St Mary's Anglican Church, and the Rideau Swans, we have been able to embraced the opportunities to support the programs that involve our youth.

The Four Rivers Cluster is once again in the planning phase and approximately every q 2 months activities have been arranged by Rev Heather McLurg Murphy who is also offering opportunities for our youth to participate not only in fun events that includes worship, music, some drama and arts and crafts, but in community building. Due to other commitments, we have only attended one other event in 2023

and that was puppet making that took place at Battersea United Church. For 2024 there is an upcoming overnight retreat for 13–18-year-olds- Feb 16-17 in Ottawa and plans to attend Rendez Vouz in St Catherine's July 3-6, are underway with the help of Dana Ducette. (Ministry of Youth and Young adults EOORC).

Elgin United also had one young adult that attended the EOORC AGM in Brockville and was part of the visioning of the rural church. I continue to believe that the voice of our youth and young adults is so important but are we willing to listen. Maybe that is our challenge for 2024. I have been very blessed to work with many of our youth who now are our young adults over the past few years and as we go forward in 2024 I continue to trust the Spirit to guide and direct the Region as I sit on YAYA's Committee, the various churches, the parents, young adults and youth. Standing together we will Embrace the Spirit and the love of Jesus and the Holy Spirit will become even brighter.

The increase is mainly because of the 6.3% increase in the cost of living for ministry personnel. # ELGIN UNITED CHURCH RIDEAU LAKES EARLY LEARNING CENTRE REPORT FOR 2023

The rental agreement entered into in 2022 by Elgin United Church (EUC) and the Rideau Lakes Early Learning Centre (RLELC) is proving, as expected, to be very positive for both parties and the community.

The RLELC has been able to expand, reducing the wait list for nursery, day-care and after school, parents have local care for their children, and the church is being used five days a week rather than only for a couple of hours on Sundays or periodically in the evening for meetings. Open communication and flexibility by both the church council and the RLELC leadership have avoided any issues with overlapping times, such as concert set-up, weekday funerals, etc.

Normal maintenance is addressed regularly and quickly, see the EUC Property Report for details. EUC applied for an Ontario Trillium Foundation grant to replace the floor in the basement great room. Our request was declined; however, we did receive a constructive debrief pointing to the two responsible issues: proof of ownership of the building and our financial statements were not signed by a certified accounting firm. We are applying again and have corrected these two factors. We remain positive.

To reiterate we thank the RLELC for approaching us at the onset and EUC Council and congregation for seeing the benefit of the liaison and supporting the initiative.

# PORTLAND UNITED CHURCH CHAIR OF COUNCIL REPORT 2023

As I look back on my two-year term as Council Chair, I am filled with gratitude for the support which all have given me. It has made the role a relatively easy one and I believe the future is bright.

My term began as our church started to revive from the impacts of Covid 19. In 2022 most of the "regular" church activities recommenced. Council, with support of the congregation, decided to continue without the services of a regular minister. This was partially due to limited supply of potential ministers, partially due to Norma Cummings and Ted Brett's success in attracting numerous presenters, partially due to the congregation's appreciation of the diversity these presenters brought, and finally the cost differential between temporary and fulltime ministers.

It should also be noted that Liz Church completed her course to become a Sacramental Elder and this allowed her to conduct sacraments for the congregation as a whole.

John Wanless has become a regular music director and his dedication in leading the choir and providing music is a great source of energy.

With the church activities underway and the decision on our minister behind us, 2023 promised to be a good year.

Two gaps appeared because of the decision to go without a full-time minister - Spiritual education and Pastoral care. As we end 2023 and start 2024, I am happy to say that a bible study group started in the fall and is meeting regularly at the church. We also benefited from Rev Powell conducting a multi-week study session in each of 2022 and 2023. Pastoral Care is still recognized as an opportunity and under Liz Church's direction will be further addressed in 2024.

The Go Green Project was by far PUC's largest physical project in 2024. With the help of a Church Extension grant at the regional level and a Faithful Footprints grant at the national level, PUC tackled a multi-pronged project to lower our overall usage of energy by weatherstripping, caulking and converting the fluorescent tubes to LED. To reduce our dependence on fossil fuels an electric heat pump was installed in the Friendship Room and to significantly reduce the cost of operations a Solar Array was installed on the roof. It will generate over 50% of our remaining electrical needs.

This project not only lowers our cost of operations but shows PUC's dedication to stewardship of this land and hopefully will help lead the way for others to take steps to help protect God's green earth.

The largest challenge I see as I look forward is harnessing the 'human energy' of the community. The congregation is small and aging but very committed. The need in the coming years will be to attract the larger community to further expand the influence of the church. The Food Bank, Clothing Co-op, Rideau sewers, and the UCW all are examples of Church activities which involve and benefit the community beyond the congregation.

PUC will continue to be an expanding beacon if the plan can continue to be developed and executed to include community members in doing God's work.

# EOORC (EASTERN ONTARIO OUTAOUAIS REGIONAL COUNCIL) 2023 ANNUAL REPORT FROM PORTLAND CHURCH REPRESENTATIVE

This year, the Regional Council has had opportunity to meet in person and continue also with ZOOM meetings. These are held on average, once a month.

There was a semi-annual meeting held in Brockville in May, and also one in Ottawa in November. Preparation for these meetings took up many hours of co-ordination, especially since we had not had an in-person one for several years.

It was my privilege to actively participate in these gatherings. One of the positions I held was as a member of a special team that was formed, called 'Setting Our Sights'. This team was tasked with preparing a strategic plan for the Region. Focusing on Scripture from Ephesians 3: 16-21 this working group of nine people met weekly for a number of months during which time a proposed plan was drafted and presented in Brockville in May at the Annual Meeting. Following this process there were 2 online consultations as well as 4 in person events in Cornwall, Ottawa, Pembroke, and Perth. The strategic plan focus was centered around six strategic objectives: Growth, Justice, Climate, Leadership, Indigenous Pathways, Common Good. Each objective was then discussed and a strategic Plan was formed. Copies of this Strategic Plan can be made available for any who wish to have this. It is exciting and well worth the read so that you can see the church of God is still active and moving forward.

One of the training sessions for 'Setting Our Sights' was held in Portland United Church. I was the host for this. It was a full day for our working group but well worth the effort.

As I continue to be one of your Commissioners on the General Council, I will tell you that we have met twice in 2023 and will meet again in 2024. Amazing events are planned and I will work at keeping you all informed.

You will know that our new moderator, Dr. Carmen Lansdowne, has been travelling throughout Canada and sharing the news about 'Flourishing Communities'. I was privileged to attend one such event in October. It was held in Kingston. Exciting news about the resurgence of churches and how we can make it happen was shared.

I have attended numerous workshops, held in Ottawa, that were training sessions on learning and sharing understanding with the indigenous members of our United Church. A special 'Blanket' ceremony was conducted at the end of the day. Very spiritual and thought-provoking.

I am sure I have missed other planning meetings, services, etc. that have been both inspiring and encouraging.

Thank you for these opportunities and occasions for learning and growth that you afford me as your EOORC representative.

#### PORTLAND UNITED CHURCH TRUSTEE REPORT 2023

The Trustees of Portland United Church continued to monitor the operations of our Church in 2023. We are primarily tasked with ensuring proper Insurance is in place and handling financial bequests, investments and memorial initiatives. We continue to thank Trustees Anita Cox and Norma Cummings who continue with the primary responsibilities of maintaining the Memorial Book in our Sanctuary and sending out Thank You notes to donors. Anyone wishing to discuss leaving a bequest to Portland United Church is encouraged to reach out to myself or any of your Trustees.

Portland United Church has a current Investment Fund of approximately \$233,000 on December 31, 2023 - up from \$220,000 on December 31, 2022 (6%). Our Investments are held by Canoe Financial. Will French and Norma Cummings act as the liaison with Canoe Financial.

In 2019, Council passed a motion that would hold withdrawals from the Long Term Fund at 6% in any given year to support the delivery of a Balanced Budget at the Congregational Annual General Meeting. None of these funds were required to be withdrawn during 2023. Of this investment, \$5000 (and accumulated interest) is on behalf of our UCW from December 2021. This was a 3 year agreement and matures in December 2024.

Insurance on the Church and its subsidiary activities at the Country Roads Community Health Centre continues to be carried by The Bay of Quinte Mutual through Rideau Insurance in the amount of \$775,000. Directors and Officers Liability continues to be carried by Hub International through the United Church of Canada. A written record and a digitally prepared record of belongings is maintained on file in both the Church office and with Trustee Katy Gibson. United Church of Canada policies on abuse and harassment continue to be made available in the Friendship Room for all to read.

The Portland Trustees continue to work with the Elgin Trustees to oversee the Manse as a rental property. Joint Trustees and designated Trustees continued to oversee the Rental of the Manse. Please see the enclosed Joint Trustees Annual Report to the Official Board.

# PORTLAND UNITED CHURCH OUTSIDE PROPERTY REPORT 2023

The main project in 2023 was the installation of the solar panels, acquiring permits and the interior work to feed our excess generated electricity back into the Hydro One grid. This was completed with the help of significant grant money that was available for this project. This also included removal of the propane-fired basement heater and replacing it with a modern interior wall mounted heating/cooling heat pump unit. Also required was the caulking of most of the exterior windows and the grouting repairs to the basement stone wall.

The cedar plank exterior Friendship Room doors were badly damaged in August but successfully repaired with the help of a local carpenter.

The main projects for 2024 are painting of exterior railings and some necessary tree trimming.

# PORTLAND UNITED CHURCH GO GREEN PROJECT

Portland United Church's (PUC) Go Green project started in Aug 2022 with a discussion around the benefits of Solar power and the Hydro 1 Net metering program.

By November, PUC council gave the go ahead to investigate. A group of four individuals, Bruce Haskin, Brad Gibson, Peter Cox and Duncan Pickard was formed and our first contact with Faithful Footprints (FF) was made. Fortunately, FF insisted we do an energy audit. This opened our eyes to the much broader impact of PUC's use of energy in general, and the use of Carbon-based fuels in particular. Building on an energy audit and actions performed in 2011 by PUC, the current audit allowed us to prioritize the following.

- Weatherstrip all external doors and recalk doors and windows
- Convert all fluorescent tubes to LED
- Remove a Propane Space heater in our Friendship room and replace it with a ductless heat pump
- Install a solar array to reduce our cost per kwh of electricity which will eventually allow a complete conversion to electric heat

With these priorities in mind PUC started costing the actions. The payback on weatherstripping was so compelling that by early February 2023, Blaine Tackaberry seized the initiative and completed this portion of the project without grant approval. In April the Church Extension grant was remitted and by

May our Faithful Footprint \$30,000 grant was approved. With financing secured, PUC transferred \$20,500 from the General Fund into a dedicated GO Green Fund. and the work to complete each of the above priorities started. All aspects of the project were completed during December 2023 within budget.

The congregation recognized the need to financially support the project and organized a number of fund raisers including 3 concerts and a Farmer's Breakfast organized by the UCW and the CEC. These activities, plus direct contributions, totaled over \$2,000.

The congregation of Portland United Church is not only excited to start receiving the financial benefits of completing the GO Green project but also proud of leading the way in a small tourist town by showing how we can all help reduce our negative impact on the environment.

We thank The United Church of Canada, through the **Faithful Footprint program**, and The Eastern Ontario Outaouais Region through the **Church Extension program** for helping United Church congregations in general and Portland United Church in particular on our journey to help protect the lands on which we live while expanding Christ's influence.

### PORTLAND FOOD BANK ANNUAL REPORT FOR 2023

Another exciting and very busy year at the Portland Food Bank. We first started the year with 22 families and by the end of the first quarter (March) we were supporting 24 families. Hoping that the Covid-19 Confinement was finally behind us, all programs were more or less back to normal e.g., Good Food Box (GFB), What's Cooking (Classes by CRCHC) and the Community Clothing Co-op (CCC). The big surprise was the constant increase in food prices, making it hard for families to make ends meet.

September marked our first anniversary at our new location (Country Roads Community Health Centre), we moved on September 12, 2022, and on September 20 we were ready to serve our clients. The move has allowed us to work closely with CRCHC and has been a successful one, so much that with the number of families we now support, we had to increase our hours without interfering with other CRCHC programs. Therefore, keeping it to the first and third Tuesdays of the month, we are now open from 9:00 am to 1:00 pm on the first Tuesday and from 10:00 am to 3:00 pm on the Third Tuesday (GFB only available after 11:00 am).

We were also asked by CRCHC to take over the responsibility of the "Community Shelf Program" located at the Portland and Westport locations. CRCHC provided the funds and Norma and I did the shopping as well as displaying in on the shelves. We also had some meetings with CHCRC and the Rideau Lakes Food Banks Network to pursue opportunities to join various program e.g., Feed Ontario and United Way Food Security. Since these programs have strict rules to adhere to which are not in line with the way we do business, we opted out and decided to pursue our own opportunities in seeking additional funds without compromising Who we are and What we do!

We had a very productive year obtaining additional financial support from various groups: Leeds Grenville Fire Department Food Drive; the International Plowing Match & Rural Expo, Simpson Lodge, etc. Also realizing that many clients of food banks may have difficulty affording pet food we were approached by Julie of Kibbles for Paws asking if we would accept donations of pet food, (pet food returned from veterinary clinics and/or slightly expired). Our clients were thrilled since many have pets and every little bit helps.

Even though we started the year with a healthy bank balance it was an unpleasant realization that we did not have enough funds to finish the year the way we wished. Compared to last year we had seen an increase of 35% in the number of families we now support (28 instead of 21 last year and 17 in 2021) and no matter how frugal we tried to be, the skyrocketing food prices, and our increased client load have caused our monthly costs to be at least 60% more than last year.

Thanks to the support of our Congregation including Portland United Church Women (UCW) we were able to finish the year without borrowing too much from the 2024 budget (money raised during Build a Mountain of Food BAM). Therefore, in preparation for BAM we did radio interviews, posted announcements on various social media groups as well as sending letters to organizations outside our community to seek additional funding or for sponsoring "hot chocolate" for the people visiting us during our BAM Food Drive.

This year the 2023 Build a Mountain of Food Campaign was held on the second Saturday in December instead of our regular first Saturday. Regardless of the timing, the Portland Community was extremely supportive and generous and as of December 2023, the total donations were \$30,414 and 2,700 pounds of food. All donations received in November and until the end of December are included in this amount. In addition to the above donations, six Food Bank families were sponsored for their Christmas

celebration, including gifts for the entire family. Two families were sponsored by Len's Cove Marina, one family by the Portland Fire Association, one family by the Portland UCW and two families were sponsored by private individuals. The six families were overwhelmed by the gifts and food they received which surely demonstrated that the true spirit of Christmas is as much in the giving as in the receiving.

Our volunteers at the Portland Food Bank were: Norma Cummings, Joan Horsfall (Portland United Church and Céline Peladeau (Chaffey's Locks), the assistance of Connie Cochran and her team as well as the Gibson Family during BAM, and the assistance of the Portland United Church Members who always step up every time we need additional help and support. Also, a big thank you to Annette Clarke and the knitters at Mill Bay Court who knitted enough items to ensure that the Clients (not just the children) had new items in their Christmas hampers.

A challenge that remains is the recruitment of volunteers. In 2023 the Portland Food Bank had only 4 volunteers throughout the year, making it very difficult when volunteers are taking holidays. However, there is hope for 2024, with all the posting on various social media in December, we succeeded in raising awareness of the Portland Food Bank, and several people have expressed interest in volunteering, and we shall strongly pursue. Thanks to Cindy Crank from Morton (who used to be a volunteer) for all the postings.

In closing, I would like to say a special thank you to Norma who is always there for me and for holding the fort while I was away in Portugal, I certainly would not have been able to survive the year without her.

The General Fund Revenue was down 10.4% in 2023, our first full year of in-person worship service since 2019. This should be a concern. We did receive 12 months of property use fees during 2023 totaling \$2,880.00, but this amount will decrease for 2024, as one group has found other facilities in the community. The Food bank continues to make extensive use of the Fund scrip program providing the General Fund with continued fundraising potential. We did have the opportunity for additional fundraising with 3 wonderful music concerts held during the summer months and the UCW Farmer's Breakfast in June. We did not require a withdrawal from the LTF for the third year in a row) to meet our obligations during 2023.

#### **General Fund Expense**

The General fund Expense was up 6.2% over 2022, but still under budget by \$8,282.00. There were some large elevator costs once again, but to be expected as it is approaching 30 years in service. The organ also required an unexpected service visit in the autumn of the year. The General fund funded \$8,000.00 (after the tax rebate) towards the very successful Go Green project. All other funds for Go Green were through direct donation and grants provided through UCC.
